Subject: Implementation of e-Bill System-regarding.

Kindly refer to letter No. 14/91/2011-5FA, dated 21-01-2013 on the subject noted above.

2. E-bill System is functional on pilot basis in Chandigarh since 01 February, 2012. The system is also being used by all the DDOs of Treasuries and Accounts Department in the entire State. Now it has been decided to extend the e-Bill system to all DDOs attached with Treasuries and Sub Treasuries in following districts:-

- (i) Panchkula
- (ii) Karnal
- (iii) Ambala
- (iv) Kaithal
- (v) Sirsa
- (vi) Rohtak
- (vii) Sonapat
- (viii) Gurgaon


In addition the e-Bill system is also being extended to all DDOs attached with Sub Treasury at New Delhi.

So w.e.f. 01 March 2013, DDOs of all the departments, which are attached with the treasuries and sub treasuries in these districts as well as sub treasury of New Delhi will also use e-Bill system for submission of the bills. A user manual for e-Bill system is already available on the e-Salary website as well as on the website www.hrtresuries.gov.in under the heading e-Bill

instructions. Training session for all DDOs attached with these treasuries and sub treasuries has already been conducted. However, if DDOs are still having any problem then they can contact the Treasury Officer in their district or the help line numbers available on e-Salary website. The DDOs can also contact Joint Director (DMC) Treasuries and Accounts Department, Haryana if they still face any problem.
