**Subject:- E-Pension System - shifting of PPOs of Haryana Government Pensioner from CPPC, State Bank of India to Treasuries/Sub Treasuries/PDC.**

Please refer to Govt letter no 02/32/2012-1 Pension (FD) dated 01-07-2014 on the subject cited above.

As you are aware that state govt has already decided to shift the ppos of the Haryana govt pensioner from banks to Treasuries/Sub Treasuries/PDC vide instruction mentioned above. Para 4 (I) of this letter reads as under:-

“The bank holding the PPO’s ..... In case the PPOs are held at central level, the PPOs will be sent back by such central branch to the Pension Disbursement Cell at Panchkula”.

Vide letter no. TA/HR(DMC)/2015/6053 dated 03-11-2015, the target of shifting of approx. 1.50 lakh PPOs from banks to Treasuries/Sub Treasuries has been fixed up to November, 2016 in view of Golden jubilee Year Celebration by the Govt.

In this regard the process of shifting of PPOs from banks namely State bank of India, State bank of Patiala, Punjab National Bank, Union Bank of India, Syndicate bank, Central bank of India to Treasuries/Sub Treasuries/PDC has been started. State bank of Patiala, Punjab National Bank are shifting PPOs from their CPPC to all the Treasuries/Sub Treasuries in the State through their respective bank branches in the field. CPPC of SBI Panchkula is shifting the PPOs to PDC Panchkula.


In view of Golden Jubilee Year Celebration and to achieve the above target, now it has been decided that CPPC of SBI Panchkula will also shift the PPOs to

all Treasuries/Sub Treasuries through their respective bank branches in the state in addition to PDC Panchkula similarly as all other above six banks are shifting the PPOs.

You are, therefore, requested to supply the information of all your bank branches under your jurisdiction in excel file for activation of userid- passwords for e-pension in the format mentioned below:

Your are also requested to start shifting the PPO's of Haryana Govt. pensioner to all Treasuries/Sub Treasuries in addition to PDC Panchkula through your respective bank branches in the State of Haryana similarly as other above mentioned banks are shifting their PPOs.
