Madam,

I am directed to refer to the subject noted above and to say that the Government of Haryana has adopted the policy decision taken by Government of India vide OM No.38/37/2016-P&PW(A), dated 12.05.2017 by the Ministry of Personnel, PG & Pension, Department of Pension & Pensioners' Welfare, New Delhi which is made applicable to members of All India Service governed by the All India Service (Death-cum-Retirement Benefit) Rules, 1958 according to Government of India, Ministry of Personnel, P.G. and Pension, Department of Personnel & Training, New Delhi letter No.14021/4/2016-AIS(II), dated 19.05.2017 to that extent for revision of pension/family pension of pre-2016 All India Services retirees of Haryana cadre w.e.f. 01.01.2016.

Therefore, you are requested to sanction the pension/family pension as per fitment table as issued by Government of India vide letter dated 06.07.2017 and send all the cases of revision of pension/ family pension in respect of IAS retired pre-2016 to the Principal Accountant General, Haryana, Chandigarh along with all relevant documents for issuing the revised PPO within a period of fifteen days preferably.
