Circular Memorandum

It is proposed to fill up vacancies in the following ranks in the Intelligence Bureau under the Ministry of Home Affairs on deputation or deputation/ promotion (composite method) basis as mentioned against each of them. The educational qualifications, experience and other eligibility conditions for the posts are furnished against each post:

1. **Senior Accounts Officer (One vacancy), group A, Gazetted, Non-Ministerial (Pay Band 3: Rs 15600-39100+ Grade Pay Rs. 6600/-) to be filled by Composite method (promotion/deputation) basis.**

Eligibility: Promotion/deputation (Composite method).

Officers under the Central Government:-

- (a) (i) Holding analogous posts on regular basis in the parent cadre/ department; or
(ii) With five years service in the grade rendered after appointment thereto on regular basis in the posts in pay band PB-3, Rs 15600-39100 plus Grade pay of 5400/- or equivalent in the parent cadre/department: and
(b) Possessing the following qualifications:-
(I) Bachelor's Degree from a recognized university; and
(II) A pass in Subordinate Accounts Service examination or Section Officers Grade examination or Junior Accounts Officer Grade examination conducted by the central Government ; Or
(III) Training in Cash and Accounts work in the Institute of Secretariat Training and Management or equivalent and five years experience in cash, accounts and budget work.

2. The departmental Accounts Officer in Pay Band-2 , 9300-34800 plus Grade Pay Rs. 4600 with seven years' regular service in the grade shall also be considered along with outsiders and in case he is selected for appointment to the post the same shall be deemed to have been filled by promotion.

Note 1: For the purpose of computing the minimum qualifying service for promotion, the service rendered on a regular basis by an officer prior to 1st January 2006 or the date from which the revised Pay structure based on the Sixth Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding Grade Pay or Pay scale extended based on the recommendations of the Commission.
