1. It is purely a stop gap arrangement and officials offered appointment will have no right to the post of SAS Section Officer (OB)
2. They can be reverted back to their parent Department on or prior to the availability of SAS qualified person or on any other administrative grounds.
3. They will not have any right/claim of regular/permanent appointment as SAS Section Officer and the pay scale and other benefit attached to the post.
4. In the matter of disciplinary action they will be strictly under the control of their parent Department. However, Director of Treasuries and Accounts Department will the right of recommendation for initiating disciplinary proceedings.
5. The appointment will not confer any right to the post of Section Officer towards pay, experience, seniority and probation etc.
