Subject:- Regarding implementation of e-GRAS.

Please refer to the subject cited above.

In compliance with the instructions issued vide Govt. Letter No. 14/80/2012-5FA dated 12.11.2013, you are directed to accept all kind of receipts through the e-GRAS system and ensure not to accept manual challan in the Treasury/sub treasury.

You are also directed to instruct the concerned treasury bank branches not to accept the manual challan from those persons who are submitting Government receipt directly into the bank without challan verification from treasury/sub treasury.

In most urgent cases in which manual challan is to be accepted then immediately contact to Sh. Sunil Bahal, Programmer, T&A Deptt. (Mobile No. 09467555388) and also email to 'treasuries@hry.nic.in' and 'deepak.bansal@nic.in'. These manual challans will be accepted after the clearance from Headquarters.

Kindly ensure to bring in the notice of all sub-treasuries/DDOs under your jurisdictions and also a notice to this effect is to be pasted on the notice board in treasury/sub treasuries. The contents of the notice is also enclosed herewith for compliance.

हरियाणा सरकार की निर्देशानुसार राज्य में E-GRAS System शुरू हो चुका है। जिसके अनुसार जिस व्यक्ति/कार्यालय प्रतिनिधि द्वारा कोई भी government receipt सरकार के खाते में जमा करवानी है वह www.hrtreasuries.gov.in under "E-GRAS" OR www.egrashry.nic.in पर जाकर challan से सम्बन्धित विवरण enter करके challan की प्रति की रिपोर्ट print out करेगा। अतः किसी भी व्यक्ति/कार्यालय प्रतिनिधि द्वारा manual challan खजाना कार्यालय/बैंक में प्रस्तुत नहीं किया जायेगा। इसके अतिरिक्त E-GRAS system द्वारा जारी किया गया चालान पर सम्बन्धित खजाना अधिकारी के हस्ताक्षर की आवश्यकता भी नहीं होगी। किसी भी व्यक्ति/कार्यालय प्रतिनिधि को खजाना कार्यालय / उप-खजाना कार्यालय में challan verification के लिये जाने की आवश्यकता नहीं होगी तथा सीधे बैंक में ही challan की print out copy प्रस्तुत करके सरकार के खाते में government receipt जमा करवा सकेंगे।
